Hoonah City School Board Meeting November 16, 2023 Principal's Report

Staff's priority and focus outside of direct instruction has been to determine the logistics of administering an effective reading (and math) intervention program, continually collecting data regarding progress, and adjusting programming as students progress in their reading skills.

Parent/Teacher Conferences occurred on Wednesday and Thursday, November 8 & 9. Teachers shared current academic progress as well as MAPS scores (Reading, Language, Math & Science) as well as Sylvan (4th-10th grade reading & math) and MClass/Dibels assessments (K-3). Those scores along with teacher and parent input provide information showing students' strengths and areas of need for those areas. Parents were invited to set up a time outside of conferences if needed and Information will be sent home via mail for parents who were unable to attend.

Reading intervention sessions will begin on Monday November 13, 2023 and will occur Monday-Thursdays 3:40pm-4:20pm and 2:10pm-2:50pm on Fridays. The District is required by DEED to provide interventions for students grades 1-3 who will benefit from a *Tier 3 level of intervention. HCSD has elected to provide reading interventions for students who would benefit from Tier 3 intervention to grades 1-10 and math interventions for grades 4-10.

Staff will participate in an all day in-service on Friday November 17, 2023. The following training programs will be provided:

- Crisis Prevention Institute (CPI) de-escalation techniques and person-centered behavior management strategies needed to create a culture of safety the school.
- ClassBright Evaluation an online performance evaluation system.

Classroom coverage when staff members need to be out of the building continues to be a challenge. Planning ahead and mapping out personal leave, professional development and other important opportunities that require absences is critical. It is likely we will not be able to accommodate all requests.

*3 Levels of Tiered Reading Instruction

Tier 2 - Students meet in small groups to receive additional support on top of their whole group (Tier 1) instruction. This instruction targets a specific skill in which the student has demonstrated a lack of understanding. The typical student eligible for this intervention strategy reads 1 or 2 grade levels below theirs and needs additional support on top of their Tier 1 instruction.

Tier 3 – Students who are eligible for this level of instruction typically do not show adequate progress in a tier 2 intervention (per data collection). He/she may require a more intense form of instruction. The instruction is more concentrated, the session lasts longer, and it is more individualized.

Tier 1 – *Wholeclass instruction (Benchmark Advance Curriculum). It is based on Alaska State Standards and is appropriate for the average reader at that grade level.*

November 2023 Special Education Report to the Hoonah City School Board & Superintendent

SPECIAL SERVICES

We completed the final count of students who qualify for special education to the state. We have a number of new referrals coming in still and students who require additional evaluations as we see the needs across the board. If all referrals qualify our special numbers will easily reach thirty-four percent of our student population. We also provide a myriad of services to homeschool students and provide creative avenues to teach students who require special services but cannot always access the general education classrooms.

The team also collaborates with our families and Seattle Children's Hospital and vision clinics, SEARHC for clinical counseling, and we have had many meetings with SESA, the Special Education Services Agency as they have created Functional Behavior Plans, Behavior Intervention Plans, Service Delivery Summaries, prevention of prompt dependency resources, restorative questions after events happened, and CCE procedures: Check, Connect, and Expect programs to provide data to extinguish negative behaviors, all with help from the staff as they fill out surveys and questionnaires.

PROFESSIONAL DEVELOPMENT

Crisis Prevention Institute training will happen Friday with each staff member. As a reminder, Crisis Prevention Institute Training, (CPI) Certification is a two-part training. Part I is online individually, and Part II is in-person with your trainer. Prevention & Verbal De-escalation Skills, Disengagement, Safety Techniques, Risk Assessment Framework, Physical Intervention Techniques, and Trauma, are all included in the training. We are running this training along with trainings that the Superintendent has also set up.

YOUR SPECIAL EDUCATION TEAM

We have a full para-educator team but due to illness or other family needs we seldom work with a full-team. Hopefully this will change as our staff is committed to our students. There are so many things we want to share but due to confidentiality we are thoughtful what to share. Along with some of the hard knocks we are also cheer on the small accomplishments and mountains our students with special needs must climb each day. Your team are doers. They clean, teach, feeds, clothes, rewards, laughs and cries, snuggling the littles who are ill or sad, modifying curriculum to come up with great ideas to foster interest, and deal with episodes of behaviors, cleaning up rooms that have been ransacked, and they still come back each day because, "Today is a new day." I am proud of the with-it-ness this team has. One of your team members Tesh Miller-Gray won the State of Alaska Inclusive Para-Educator Award a few years back and another staff member is nominated this year. This person is becoming known across the state as an excellent para educator. We will let you know the outcome!

Board Report:

FASFA Conference:

Free Application for Student Financial Aid, FASFA, is the pathway to finding a student's postsecondary education. In Alaska FASFA ranks number 50 in application completion. Each year Alaskan students and their families often begin the application and do not complete. Last year alone students across the U.S left over \$17 Billion on the table. Alaska left over \$7.5 million in grants, scholarships and loans on the table.

The take away from this collaborative team meeting: all students in 11th and 12th grade should complete a FASFA application. These applications for many of our students will provide them with Scholarships and the Pell Grant. Students can use these fund to pay for licensure programs such as Cosmetology, Hairdressing and Barbering School. They can also pay programs that are available through the any university.

I have attached a list of FAQ's for review.

The Plan for Hoonah students: To Host a FASFA information night in early January And a full FASFA application day with assistance In mid-February.

On boarding with SERRC: I met with Chris Giron of SERRC. He came out for a site visit so we could accurately form a baseline on the school facilities energy consumption. Also, during the site visit, Chris introduced me to the preventive maintenance system SERRC offers which helps us stay ahead monitoring and maintaining key building systems: HVAC, electrical, safety illumination, and fire systems.

Site Organization: Since I have come on board, I have restored order to areas around the facility, namely the mechanical rooms and others which were used for "catch-all" storage. Efforts for general maintenance and tidiness are ongoing and are part of my daily routine.

HVAC balancing and upgrades: The contract has been awarded to *Turbo Construction*. This is great! I have spoken with Dave from Turbo. He is very knowledgeable and aware of our current HVAC needs. I have confidence in Dave that he will do a stellar job for us. On completion of the project, our HVAC systems will be running optimally and ultimately cost less to operate.

On the technology side: we have new state of the art equipment in our classrooms. Each classroom has a new "Optoma" 75" touch screen complete with Mac minis and cameras. These are ideal for 21 century learning and collaboration. Major shout out to Helen, the D.O., Ryan, Jesse, and others for getting that done!

AASB Training Session Dec. 15th and 16th. For all Board Members - It is wonderful that we have all agreed on the dates. Jenny from AASB, will be here on-site for these two days.

Acellus grant - 1 year - We were awarded a \$10,000 grant to upgrade 12 students from a basic program to a "Gold" program. The new program offers more student engagement. The basic cost is \$2,700 for the entire district, and the Gold program is \$800 per student. The admin team will be meeting to determine how best we can utilize these upgrades.

Hydroponics grant - 1 year - We also received a \$10,000 grant for a new hydroponics system. The new system will be shipped in February, complete with everything we need to grow a garden and help contribute fresh green for the students, grow flowers for selling, and provide seedlings to the community to give them a start on their gardens in the spring.

4th-grade classroom renovations over Christmas - This classroom was two classrooms, and it had a retractable wall. The retractable wall was removed, but it made the room too large. Over Christmas break, the Maintenance Director will construct a wall so that we can have two full classrooms again. We are going to use the new classroom to house the hydroponics units.

Civics grant - 5 students going to Close in D.C. (3-year grant) Teachers to RTI, New Alaska Social Studies standards roll-out, New CIVICS curriculum written for Alaska - Five districts are included in this grant, and all the Social Studies teachers will be working together to make this happen over the next three years.

K-5th grade teachers want new Math Curr. (HS states that theirs are working) - We will start evaluating a new Math curriculum while we still can use the COVID funds.

RTI in January Type-A teachers are going - We have a grant to pay for 3 administrators to attend and 10 Type-A teachers. This is January 27th and 28th. More news to follow as the time gets closer.

Veterans Day luncheon - There will be a Veterans Program on the 10th starting at 10:00 a.m. The Veterans will be invited to stay for a special luncheon after the program.

New devices are now in the classrooms – Friday, November 3rd, all the staff had their first training session on how to use them. We are giving them a few weeks to discover them, and then we'll hold the second training in a few weeks.

Smart Boards - going to Huna Heritage, community center, HPC, and Daycare - still have plenty to donate

Para's injured - We had three para's sent to the clinic over the last two weeks, and we are still awaiting quotes for the new camera system. Five emergency cameras have been ordered from Amazon.

Cameras – SERRC has the quote for the cameras but cannot find a certified electrician to install them. Question:

Would the board allow our Maintenance Director to install them?

HVAC bids - We have received two quotes after six weeks of waiting for quotes. One was for \$365,000, and the other for \$616,000. The Board awarded Turbo Construction in the amount of \$365,000.00

Flooring in the gym - Where we are in this process - The flooring folks are trying to find a contractor to do the demolition. I told them I would bring this back to the board for suggestions. I am hoping for some local contractors that want to assist.

Teacher Appreciation Night - Friday, Nov. 3rd - Dianne did an excellent job. She invited local elders to mentor individual teachers to assist in the transition of living, not only in Alaska but in Hoonah.

Welcome celebration for 4th grade teacher, Thursday, Nov. 2nd. This was also a nice welcome party for Mr. Johnston. Ms. Egan worked hard to invite the staff and the 4th-grade parents for an introduction. It was a short party, and Ms. Egan served snacks for everyone.

November Family Engagement Night, Tuesday, Nov. 14th -

Student scores - The letters went out to parents for the students who need tutoring. Fourth and tenth-grade students will have access to 40 minutes of after-school tutoring, and 1st - 3rd-grade students will have access to interventions with teachers.

MAP scores, Sylvan scores, and Alaska Science Scores were given to parents during the conferences on Nov. 8th and 9th.

Sylvan tutoring starts Nov. 13th. - Parents will be notified at the Parent/Teacher Conferences regarding their student scores and be given the opportunity to sign their child up for tutoring. This is optional, but it is essential that we provide this service for our students. We have 44 students who qualify for these services.

Icy Strait Point donated \$22,960.04 to our Activities Funds. The check was presented at a school-wide assembly.

The Alaska Science Assessment is administered annually statewide to students in grades 5, 8, and 10. It provides students the opportunity to show their understanding of the skills and concepts outlined in the <u>K-12 Science Standards for Alaska</u>, which were adopted in 2019. The assessment provides information to parents, educators, policymakers, communities, and businesses about how Alaska's schools and districts are performing. The Alaska Science Assessment also provides information to help schools improve and to meet Alaska's educational mission, "An excellent education for every student every day."





The number in the box indicates the student's scale score. *Please note*: If the student did not attempt the test or if the student did not receive a valid score, a Student Report will be generated. The horizontal bar graphically illustrates the student's scale score and the location of that score in the achievement level attained by the student. The dark circle in the symbol (---) represents the student's actual scale score. The bars on the side of the circle represent the range of where the student's score would likely fall if the student were to test again. This represents the standard error of measurement (SEM).

Scale Score: A number that provides a common metric for expressing student performance. The student's overall performance on the Alaska Science Assessment is reported as a scale score. Points earned by answering an item correctly are converted into a scale score that takes into consideration the difficulty of the item.

Standard Error of Measurement (SEM): The SEM provides information about the level of confidence that a student would achieve the same score if that student tested again on an equivalent form of the test without changing knowledge or skills. The SEM is specific for the particular grade.

This section describes the student's achievement level as determined by the scale scores reported

in **B**. Student performance on the Alaska Science Assessment is reported in one of four achievement levels. These levels describe the performance of the student on the standards tested at the grade level. The four achievement levels are:

Advanced (A)—Student meets the standards and demonstrates mastery of the knowledge and skills on a range of complex grade-level content.

Proficient (P)—Student meets the standards and demonstrates mastery of the knowledge and skills of most grade-level content.

Approaching Proficient (AP)—Student partially meets the standards and may have gaps in knowledge and skills but is approaching mastery of some grade-level content.

Needs Support (NS)—Student may partially meet the standards but needs support to master the knowledge and skills of current grade-level content.

- This section shows the student's scale score and how it compares to median scores at the school, district, and state levels. The median represents the middle score in an ordered list of scores. Half the scores are above the median and half are below. The median is used instead of the mean (or average) because it is more stable if there are some extremely high or low scores in a group.
- F This section shows a comparison of how the student performed in the reporting categories. The symbols indicate how the student performed compared to students who score just barely at the proficient level.
- G This section shows the Performance Results Key, which provides the meaning of the number of stars that appear in the Reporting Category section. The K-12 Science Standards for Alaska are expressed as Performance Expectations that define what students should know and be able to do at the end of instruction. The Alaska science standards emphasize three distinct dimensions that help students learn science: the fundamental scientific knowledge, the practices scientists and engineers use to explain the world or solve problems, and scientific thinking across disciplines. Reporting categories are a subset of content knowledge and skills within a subject area. The reporting categories for grades 5 and 8 are Life Science, Physical Science, and Earth and Space Science. Grade 10 reporting categories are Life Science and Physical Science. You can use these reporting categories to start a conversation with your child's teacher about their progress in science.

This section provides general descriptions of what a student in this grade level can do at each achievement level. Find the student's achievement level at the top of the report and read the description to learn more about the content and skills that the student demonstrated and see what content and skills would be demonstrated by students reaching a higher achievement level on the Alaska Science Assessment. BP 5112.5 OPEN/CLOSED CAMPUS

The School Board establishes an "open campus" at district middle and high schools. By allowing our students to leave campus during the lunch period, the School Board entrusts them with an opportunity to learn responsibility and demonstrate good citizenship. Students shall not leave the school grounds at any other time during the school day without written authorization of their parents/guardians and permission of school authorities. Students who leave school without such authorization shall be classified as truant and subject to disciplinary action. Due to the legal responsibility of the school, students may not drive vehicles at lunch or during school hours without prior written permission of both parent/guardian and the principal.
